## 348 TO DISCUSS PARISH COUNCIL MACHINERY

Councillor Kevin Cuffley welcomed Will Cook (Head Grounds Keeper) and James Drummond (Grounds Keeper) to the meeting. Will Cook gave an update on their work to date and explained that he would like to replace one of the mowers. We have a ride on cylinder mower which is around 23 years old. He went on to explain that cylinder mowers only really work on short grass and therefore areas must be cut more frequently for the mower to work appropriately. They would like to replace this mower with a rotary mower which can cut various lengths of grass and can mow over twigs/debris that would damage

the cylinder mower. To repair the cylinder mower when needed would cost around £2-300 each time whereas if the blades were blunted on a rotary mower, they would be able to sharpen the blades and maintain in house. A rotary mower will cut grass from long to short more efficiently and will be beneficial and cost effective to the parish council. This mower is also road legal.

There is nothing wrong with the current mower and the Cricket Club have shown an interest in purchasing it or the parish council could trade it in.

They investigated an electric equivalent, but these are not road legal and it is recommended to have two batteries for one mower and these batteries can cost up to £15k each.

Councillor Brian Milnes suggested the parish council investigate HVO replacement for diesel if we do order a new mower as this is almost 100% emissions free.

This was discussed at length and the Clerk confirmed there was money in reserves for new machinery to cover this expense.

Three quotes were obtained.

- £19750.00 + vat
- £19593.00 + vat
- £18970.00 + vat

It was **proposed** by Councillor Kieran Cooper and **seconded** by Councillor Kevin Cuffley to accept the quote for £18970.00 from TNS and contact the Cricket Club about purchasing the old mower.
