## 6 TO DISCUSS PLANTING A TREE FOR THE QUEENS PLATINUM JUBILEE

The Clerk suggested we plant a tree within the village with a plaque to celebrate the Queens Platinum Jubilee. It would be nice if this was planted outside the office but she will check with the grounds keeper first to see if there is an area suitable at the office.

It was **proposed** by Councillor Neil Reid and **seconded** by Councillor Anand Pillai to **RECOMMEND TO FULL** to plant a tree and purchase a plaque to be located outside the office to celebrate the Queens Platinum Jubilee The Clerk will get confirmation from the grounds keeper first and will have prices before the full parish meeting.

## 7 TO DISCUSS INSTALLING PLANTERS IN THE HIGH STREET

The Clerk explained we have previously discussed installing large planters in the High Street to improve its appearance. She had contacted the County Council as we would need to ask permission before installing them if we did decide to go ahead.

The Clerk asked the committee to send her suggestions of where the planters could go and she will then seek permission and costs. This will be an agenda item for the Planning and Environment meeting in March.

#### 8 TO DISCUSS CAMBRIDGE CITY FC GIFTED LAND TO THE PARISH COUNCIL

Councillor David Bard explained that Waterbeach Instruments Limited has sent a letter to the Parish Council with an outline specification of the gifted land as part of Cambridge City Football club's planning obligation to develop the land. The decision to accept this land should be made by the full council and it was therefore deferred to March full parish.

#### 9 TO DISCUSS EXTENSION OF RESTRICTED ROAD SPEED LIMIT ON BABRAHAM ROAD

Councillor David Bard explained that the County Council are proposing to make an order under relevant sections of the Road Traffic Regulation Act 1984, to extend the 30mph speed limit on Babraham Road approximately 360m eastwards, to the edge of the new developments. This was discussed.

It was **proposed** by Councillor Ian Reeves and **seconded** by Councillor Paul Smith to **RECOMMNEND TO FULL** that in principle we believe a 40mph speed limit should be instituted on Sawston Road between the edge of the new developments and the junction with Babraham High Street It was also proposed to write to Pampisford and Babraham parish councils to let them know our recommendation.

# 10 TO DISCUSS RESIDENTS REQUEST TO PLANT TREES ON VERGES

Councillor David Bard explained that a couple of residents have asked if they can plant trees on the verges within the village.

1 Lynton Way 6 Churchfield Avenue 22/24 Churchfield Avenue

The clerk explained that she would need to seek permission from County Council to have these planted but they are very happy to see new trees planted.

It was *proposed* by Councillor David Bard and *seconded* by Councillor Ian Reeves to plant the trees in these locations providing we have permission from County Council.

# 11 TO DISCUSS WATER POLLUTION

Councillor David Bard explained that there had been press reports of water pollution by perfluorooctane sulphonate (PFOS) in other villages especially Stapleford and Great Shelford.t was noted that Sawston wasn't affected but we are aware of the problem in the surrounding villages.

Councillor Brian Milnes arrived 7.50pm during this discussion and confirmed that Sawston had not been affected and that the problem had now been addressed. At no time had PFOS contamination reached hazardous levels.

#### 12 TO DISCUSS RESIDENT REQUEST TO PURCHASE LAND AT THE SIDE OF 2 SAFFRON ROAD

Councillor David Bard explained that a resident had requested to purchase a strip of land to the side of 2 Saffron Road and to incorporate this into their garden. This was discussed and Councillor David Bard expressed concerns that if this were allowed it would set a precedence for others to make requests. It was noted that the Parish Council had objected to similar requests in other parts of the village.

It was **proposed** by Councillor Neil Reid and **seconded** by Councillor Brian Milnes to **OBJECT** to this application due to the effect on the street scene and that the green areas are left for a purpose.
